GOVERNMENT

While many of our elected offices have been filled with progressive ideologists, we did have several local, state, and federal offices won by candidates that adhere to Biblical values: 2 NYS Supreme Court positions, 1 seat in the Monroe County Legislature, and 11 miscellaneous Town races. (2) The state level wins are: 3 NYS Assembly seats, 2 NYS Senate seats, 2 US Congressional seats, and several Long Island positions. (3) Federally there were 20 Senate, 18 Governor, and several House seats won by those who still believe in the Bible and our founding documents. (4)

SCIENCE & TECHNOLOGY

Arkansas is the first state to ban gender reassignment surgery for minors under the age of 18, with 15 other states having similar bills waiting to be voted on.⁽⁵⁾ Arizona is the latest state passing a bill that delays any irreversible gender reassignment surgery until age 18.⁽⁶⁾

FAMILY

Disney's newest film "Strange World", featuring a gay teen romance, was a big flop over the Thanksgiving holiday. Parents are getting tired of the woke agenda and sexuality. The film is projected to LOSE about \$100 million. (7)

RELIGION

The Christian Medical & Dental Association has won a six year Christian liberty battle against the U.S. Department of Health and Human Services. The case of Becerra vs. the Franciscan Alliance, "pushed a controversial transgender mandate, threatening religious doctors and hospitals with penalties unless they perform gender transitions, violating their conscience." A nationwide precedent was set with this victory!⁽⁸⁾

EXPOSURE TO NURSING HOME ABUSES DURING COVID CONTINUES FAMILY

Did you lose a loved one in a nursing home during the pandemic? Were you frustrated and outraged by the fact that you were prevented from visiting them and being involved in their care and treatment? Well, some families have chosen to sue the nursing homes, in an effort to hold them accountable for these horrendous deaths.

According to a recent article, dated 11/21/22, "US Supreme Court Rebuffs Dispute Over Nursing Home Covid Suits," one such family has filed a lawsuit. The family of Ricardo Saldana is accusing the facility of his death in 2020, elder abuse, willful misconduct, and negligence. The article states:

"A recent decision by the U.S. Supreme Court has denied Glen Haven's appeal of a lower court's decision, allowing their lawsuit to proceed at the state level."

"Adam Pulver, a lawyer for the family, said that he hoped the decision would lead the nursing home industry to give up the 'delay tactic' of trying to move lawsuits related to Covid-19 into federal courts, and 'allow families to have their day in court.""(1)

Another article titled, "US appeals court Rules Against Nursing Homes Over Covid-19 Lawsuits," 10/21/21, stated:

"In a setback to nursing home operators facing hundreds of Covid-19 negligence and wrongful death lawsuits, a federal appeals court on Wednesday said cases against two New Jersey facilities should proceed in state courts."

"The cases were filed in state court in April 2020 by families of four residents who died of Covid-19. They sued two nursing homes operating as Andover Subacute and Rehabilitation I & II, alleging the facilities failed to take precautions to contain the spread of the virus."

"The cases were among the first against nursing homes, where more than 100,000 people died during the pandemic. Like hundreds of similar wrongful death claims against care facilities, the cases stalled over which court should hear the lawsuit."(2)

These are just two examples of the many lawsuits that are moving forward in an effort to expose the lies & bring justice to the victims' families.

THE NEXT P(I)ANDEMIC

It looked like Monkeypox was going to be the next p(l)andemic destined to bring destruction on the human race, but that disease seems to have fallen by the wayside and abandoned by the WHO as it was exposed as uncomfortable, not deadly, and rooted in the gay man's population.⁽¹⁾

To better prepare for future p(I)andemics, the G-7 (The U.S., Canada, France, Germany, Italy, the U.K., and Japan) announced the Pact for Pandemic Readiness at its annual summit this past June. (2) They propose to train scientists and healthcare workers world-wide to create a global network that can collaborate on outbreak detection and control.

They base their scientific conclusions on the notion that animals and humans are living closer to each other ("overpopulation" and "climate change") causing diseases to jump from animals onto humans.⁽²⁾ (Covid has already been proven to have originated in a lab in China with Dr. Anthony Fauci's funding.)⁽³⁾ So, the more "climate change," the more p(l)andemics. We can trust they will never back off on climate change—which is itself highly debated in the scientific community.⁽⁴⁾ In addition they created a more lethal strain of COVID in a Boston lab.⁽⁵⁾

So, what's next? I don't think we know. Study purchases made by countries preparing for the next p(I)andemic. ACT-A (Access to COVID Tools Accelerator) was set up by WHO and partner organizations early on in the p(I)andemic to allow for a more equitable marketplace for all countries. This international collaboration suggests that something is in the works. Pfizer made \$54 billion alone off the shots and boosters in 2022.⁽⁶⁾ They and cohort industries make profits off the failures of the original jab with the boosters that, incidentally, do not protect. They are slyly called "vaccine breakthroughs".⁽⁷⁾

We do know that after the flu epidemic of 1918 the frequency and amount of viruses circulating have greatly increased. Historically, they have appeared hundreds of years apart. The Spanish Flu was 1918-20; the Asian Flu in 1957; 1981 brought AIDS. Since then we've had four^{[(8)} Dr Fauci, who pushed the covid shot, whose treatment with Remdesivir has brought many deaths, likewise also introduced AZT to treat AIDS—which was shown to have "horrendous toxicity" causing death. And just like todays' covid shot, it was rushed through with minimal testing.⁽⁹⁾

Perspective after 6 weeks in Developing Nation (Malawi, Africa) By Candy Giles

Most Americans have electricity and hot/cold running water 24/7. Homes and businesses in Malawi that are hooked up for electricity experience frequent blackouts. On Sundays you can usually count on a long day without power. Many poor people live with no electricity at all and carry water from a well or spring.

Corruption is rampant. Yes, America has its share, but I talked to a contractor who has done jobs for the government and waits for payment because middle men hope for a little side payment. So this leaves him without funds to start a new job or pay his workers. The cycle of poverty continues. For one job he had to hire a lawyer to get payment! The vice-president was just arrested for corruption and faces a possible 12 years in prison. He's probably just a scapegoat to protect others, even above him.

Gas is \$8 a gallon! Sometimes it's scarce and people park their cars in a line at the gas station and wait to hear that a shipment has come in. Police are at the pumps to stop people from filling gas cans (for hoarding or black market).

The main roads are usually two skinny lanes with lots of bicycles to avoid as well as animals and pedestrians.

Walking long distances in hot weather is normal. I spent my time at an orphanage. The children walk 3 miles one way to church. The youngest was about 6 years old. High school kids can walk an hour or more to school. It's just what you do, and willingly, because most really value their education. If you can afford a "cab" the most common way is to ride on the back of a bicycle.

Stealing is rampant. Those you really trust can be counted on one hand. Poverty is of course a factor. The same contractor mentioned above hires guards at his worksites and still equipment and materials are stolen, sometimes by people he trusted.

This is not to slam Malawi. The poverty and lack are heartbreaking but the land is beautiful and the people loving and joyful. Church is a praise experience. Small gifts are *appreciated*. For children a big treat is a slice of an orange, a lollipop, or a page to color. A plastic bag is a treasure. I was burning my garbage and a mama came running to get the plastic bag before it went up in flames.

There are many causes for the extreme poverty (including foreign aid and well meaning but misguided "do gooders")^(1,2) and behind it all is an Enemy causing spiritual darkness that needs the light of Christ. We have so much more in America than we realize!
