In September of 2001, Dutch Sheets had a vision where Acts 3:19 appeared on the wall of an auditorium where he was speaking. “Repent...so that times of refreshing may come.” Dutch then had a vision of fires of revival at schools and colleges around the nation. God’s love came “to save this generation” and he heard “nothing can stop it.”

He saw healings, deliverances, and salvations—with no formal plan or leader. He saw that there were *so many* young people who were seeking Jesus, without wanting religion, that it will be difficult to steward. “It will be like the book of Acts.”⁽¹⁾

Dutch Sheets is just one of *many* prophets who have said for years that the greatest revival of all time is coming. Perhaps now is the time.



On February 8, 2023, at Asbury University in Wilmore, Kentucky—a regular chapel service never ended. The speaker finished but a few students stayed and continued to worship and pray. The powerful presence of the Lord attracted more students and faculty—who didn’t want to leave. Many stayed all night to be in God’s presence. As days went by, 20+ other colleges brought their students to Asbury believing for an impartation.⁽²⁾

Hunger for Jesus, salvation, repentance, physical & emotional healings, a “blessed stillness,” holy and peaceful worship, prayer, and lack of formal leadership are some descriptions. A movement of young people, but all ages are coming to Asbury, from across the country and around the world. Separate buildings were opened for overflow, with long lines outside waiting to enter. News crews were asked not to come. Offerings were not received.⁽²⁾ Within days, other colleges were having similar gatherings.⁽³⁾ And revival has been reported outside the US.⁽⁴⁾

After two weeks the college decided to limit the 24/7 meetings for many reasons.⁽⁵⁾ BUT...“The outpouring at Asbury was never intended by Holy Spirit to be the only place where revival occurs in America. What He has planned will occur all across our nation and other nations...Asbury is only the beginning.”⁽⁶⁾ So many people have been believing for revival for years. At times it seemed it would never happen. But this is just the beginning and we should be encouraged and continue to hope for revival and for more prayers to be answered.

This move of God is ongoing and changing daily. Testimonies of this movement are on Asbury’s Facebook page and on YouTube. You can also find accounts of revival spreading to Australia, Uganda, Philippines, etc. on YouTube. And to this we say, “Yes and Amen!”

On January 1, 1802, Thomas Jefferson wrote, partly to the Danbury Baptist’s Association of Connecticut: “Believing with you that religion is a matter which lies solely between Man and his God, that he owes account to none other for his faith or his worship, that the legitimate powers of government reach actions only, and not opinions, I contemplate with sovereign reverence that act of the whole American people which declared that their legislature should “make no law respecting an establishment of religion, or prohibiting the free exercise thereof,” thus building a wall of separation between Church and State.”⁽¹⁾

This “wall of separation” is often quoted by those who seek to eliminate any public form of expression of faith. But what is this “wall”, and is it the best metaphor for what the actual text of the 1st amendment says? To answer, we must understand the concerns of the Danbury Baptists

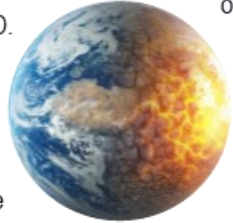
DO YOU BELIEVE IN CLIMATE CHANGE?

Do you believe in climate change? I do. Let us go back 1100 years, around 900AD. You would find a warm period in history. It was warm enough that the Vikings sent out colonies to Greenland. And Leif Erickson made his way to North America.⁽¹⁾

Now let's go from 1300 to 1850AD. Among geologists, this era is called "The Little Ice Age."⁽²⁾ Average Earth temperatures dropped. Some areas were unaffected because glaciers were advancing. Some areas had increased rainfall, while other areas suffered from drought. Climate definitely has changed.

Our Earth does undergo temperature changes. The question becomes: is our current "global warming" due to the industrial revolution, changes in solar radiation, a combination, or other factors?



What do you know about the Paris Climate Accord?⁽³⁾ The Paris Climate Accord's long-term temperature goal is to keep the rise in mean global temperature well below 2°C. Emissions should be reduced as soon as possible and reach net zero by the middle of the 21st century.

WHISTLEBLOWERS—CORRUPTION EXPOSED

In early October, Apostle Tim Sheets had a vision and heard the Holy Spirit say “the whistleblowers will now be heard.”⁽¹⁾

1. Dozens of FBI whistleblowers have flooded the office of Congressman Jim Jordan, chairman of the House Judiciary Committee. They have exposed the FBI's involvement in the suppression of the Hunter Biden laptop story, attacks on Trump supporters from the January 6, 2021 rally, creation of the “Russia hoax” against Trump, attacks on parents for speaking out at school board meetings, and their heavy influence on Twitter to suppress information that would hurt Joe Biden.⁽²⁾⁽³⁾

2. THE UNITED STATES IS RESPONSIBLE FOR DESTROYING THE NORD STREAM PIPELINE!

The pipeline runs through the Baltic Sea carrying gas from Russia to Germany. It exploded in September 2022. This environmental and human disaster leaves much of Europe without necessary fuel. This was reported by investigative journalist Seymour Hersh, a former New York Times reporter, who alleged, “Last June, Navy divers...planted remotely triggered explosives, that three months later, destroyed three Nord Stream pipelines.” The Biden Administration found a way to do this without having to report to Congress⁽⁴⁾⁽⁵⁾ The U.S. government denies this report, but there are sources with details to prove it is true.⁽⁶⁾

EQUALITY VS EQUITY

“We hold these truths to be self-evident, that all men are created equal, that they are endowed by their Creator with certain unalienable Rights, that among these are Life, Liberty and the pursuit of Happiness.--That to secure these rights, Governments are instituted among Men, deriving their just powers from the consent of the governed,” Declaration of Independence July 4, 1776.

This declaration, written by a committee of five men (Adams, Franklin, Jefferson, Sherman, and Livingston), and adopted by the 2nd Continental Congress to gain independence from the tyrannical rule of King George III, listed in its body, 27 grievances against the British Crown⁽¹⁾. After much bloodshed, we gained our independence and began our journey as a free country where all would be treated the same and given the opportunity for success. All things not yet perfected, we would spend the next 200+ years righting our wrongs to achieve the goal of equality for all.

Currently, as the woke ideology has taken hold, a new term has emerged—*equity*. A general definition of it is ‘justice’ or ‘fairness.’ On January 20, 2021, President Biden signed Executive Order #13985 Advancing Racial Equity & Support for Underserved Communities. This order defines equity as “the consistent and systematic fair, just, and impartial treatment of all individuals, including individuals who belong to underserved communities that have been denied such treatment.”⁽²⁾ To all fair-minded Americans, this is a beautiful thing. Who wouldn't want to help disadvantaged people make a better life for themselves? But in the hands of a corrupt government whose goal is to “fundamentally change America,” “helping specific demographics means hurting and discriminating against others.”⁽³⁾ The most current blatant example of this is the plan to implement AFFH (Affirmatively Furthering Fair Housing) which would force town governments to change neighborhood zoning laws to disallow single-family homes and allow for low-income high-rise apartments. Non-compliance would result in Federal Funding being withheld from those towns, essentially destroying the suburbs. Gov. Hochul will begin implementing this plan in the NYC Metro area.⁽⁴⁾ In the name of “equity” some schools in Virginia withheld notification of academic achievement awards from mostly Asian students.⁽⁵⁾ On February 16, 2023, President Biden signed another E.O. giving every Federal Agency 30 days to create “Equity Teams” to monitor the equity progress.⁽⁶⁾

There are several alarming trends taking place in the religious arena.

Antisemitism, according to the Anti-Defamation League, is on the rise in America. The Jewish anti-hate organization's annual audit of anti-semitic incidents showed a 34% increase—including incidents of assault, vandalism, and harassment—year over year from 2020 - 2021. In total, the ADL recorded 2,717 antisemitic incidents in the U.S. last year, the most since the organization began tracking in 1979. There is religious, political, social, economic, and racial antisemitism. In periods of national insecurity (Covid, inflation, etc.) it's always easy to make scapegoats out of smaller populations.⁽¹⁾ America's gone from "Never Again," referencing the horrors of the holocaust, to "here we go again."

The Church of England has adopted some horrifying theology. They have cast aside biblical teaching and are embracing homosexuals in leadership⁽²⁾, same-sex unions (even among priests themselves), and feminine pronouns, so that God may be "more inclusive."⁽³⁾ The Pope holds views that are so liberal they lean globalist, causing a major fracture in the Catholic Church.⁽⁴⁾

In February 2021, the Satanic Temple of Texas filed a suit to defend its religious right to engage in abortion (child sacrifice) as a spiritual ritual. Abortion is legal in Texas, up to 20 weeks, unless it is a life-threatening event—then a sonogram and paperwork detailing medical risks, adoption options, and other counseling information are required to be offered followed by a 24-hour wait period. The temple members consider abortion a ritualistic practice and maintain that the State disrupts this ritual. The "imposition" of the Texas law amounts to "a violation of our (Satanic) religious liberty."⁽⁵⁾ This is frightening. Then what is to prevent a female Satanist from carrying a baby only to purposely kill it for "religious" reasons?

within the context of their times.

America hasn't always been tolerant and open to religious expression. Unfortunately, various groups sailed to America in the 1600s bringing with them the same persecutions that drove groups to America for religious freedom. The English Puritans settled in the New England area, established the Congregational Church, then engaged in persecuting Baptists. Laws enacted in Massachusetts made preaching against infant baptism illegal, and instituted taxes to raise revenues for the "official" Congregational Church.⁽²⁾ Baptists refusing to pay, were fined, their land seized, and they were run out of town. In one case, a Baptist received 30 lashes for preaching against infant baptism.⁽³⁾ It was the sectarian nature of these laws that concerned the Danbury Baptists, not the general teaching of Christian morality or the Gospel message.

In future editions, I will demonstrate that the framers of the US Constitution never intended that the Judeo-Christian Moral Ethic be divorced from considerations of the laws of the nation.
