
OPENING PRAYER: THE FIRST CONTINETAL CONGRESS

WHAT IS IN YOUR FOOD? By Ken Wolf

In the past, my wife had cancer. She no longer has it. We have changed our eating habits to help prevent it from coming back. We try to eat organic foods, avoid foods grown with pesticides, and avoid foods with artificial additives. Everyone has to decide on their "tolerance" to food manipulation.

Here are just some examples (there are more) that are worth looking at:

TWO VARIETIES OF PESTICIDES:

Glyphosate: 'Big Ag' (big agriculture) uses it as a weed killer in their fields. Here are several (not all) GMO crops that were made to be glyphosate resistant: corn, soybeans, cotton, and sugar beets. Glyphosate has been associated with non-Hodgkins Lymphoma and other cancers. (1) Note that when a plant is glyphosate resistant, it means the plant can tolerate larger amounts of the pesticide. Farmers can apply larger amounts of the glyphosate to their fields. These GMO plants can take up large amounts of glyphosate and still live.

Neonicotinoids: These are insecticides suspected of damaging bee colonies. (2)

FOOD ADDITIVES:

Aspartame: An artificial sweetener used in diet drinks and food. Some research suggests that aspartame increases the risk of type 2 diabetes, toxicity in the kidneys, and more.⁽³⁾

Food Coloring: A report released in April 2021 by the state of California confirmed the suspected belief that the consumption of synthetic food dyes can cause hyperactivity and other neurobehavioral issues for some children.⁽⁴⁾

LIVESTOCK

mRNA Vaccines have been used in pigs since 2018.⁽⁵⁾ These vaccines (which have not had proper testing) are now being developed for cattle and chickens.⁽⁶⁾

EDIBLE VACCINES

The future of vaccines may look more like eating a salad than getting a shot in the arm. UC Riverside scientists are studying whether they can turn edible plants like lettuce into mRNA vaccine factories.⁽⁷⁾

Other controversial items/additives to consider are preservatives, fluoride in our water, and antibiotics and hormones fed to livestock.

Buyer beware. Read labels. Your dollars affect the way your food is produced.



A BOOK REVIEW by Candy Giles THE COURAGE TO FACE COVID-19 By John Leake & Dr. Peter McCullough

Seldom does a non-fiction book keep me turning pages to read what comes next. Perhaps living through the event contributed to its interest. The Courage to Face Covid-19 reads like a mystery novel.

The book is primarily the story of Dr. Peter McCullough, a world-renowned cardiologist and epidemiologist. He was the vice-chief of Internal Medicine and program director of Cardiology at Baylor Hospital, in Dallas, Texas. When Covid-19 hit he looked for early treatment options. Standard medical practice was to send patients home and if they got sicker, then it was to the hospital where the treatment was remdesivir and a ventilator. Mortality rates were high.

Dr. McCullough felt alone in his search for early treatment but did find some other like-minded do ctors. Dr. Vladimir Zelenko and French Professor Raoult were two of the most well-known. They were using early treatments such as

hydroxychloroguine, antibiotics, and ivermectin.

The book tells of many inexplicable obstacles the doctors faced. False "studies" and narratives about early treatments plus smears/lies about the doctors themselves shocked them.

Dr. McCullough made YouTube videos about successful early treatments and testified both in Congress and the Texas legislature. His hospital did not approve and eventually, he was terminated after serving years as an esteemed doctor.

Dr. McCullough is no right-wing conspiracy theorist. He voted Democrat. But he saw the collusion between the government, pharmaceutical companies, the media, and hospitals to make enormous profits from the vaccine. Hospitals were paid extra for every patient who tested positive, took remdesivir, or went on a ventilator. And the payout was especially large when someone died "from Covid".

Looking back, I believe my 96-year-old mother was used for profit by Baylor Hospital. She went for internal bleeding, but "tested positive" for Covid day after day without symptoms. There she passed away, with 'Covid' written on her death certificate!

This book may infuriate readers, but the truth needs to come out. It contains facts proving that Peter McCullough and other doctors were right (and on the right side of science)!

DONALD TRUMP, POLITICAL PRISONER By Candy Giles & Barbara Sieber

On April 4, former President Trump was issued "an indictment based on non-crimes and politics that was (even) weaker than his critics thought," said Tom Fitton of Judicial Watch.(1) The Federal Election Committee also has said there is no campaign finance violation as alleged.(2)

Former liberal Harvard law professor, Alan Dershowitz said, "There is no part of this case that isn't weak."(3)

Manhattan DA Alvin Bragg, (funded by George Soros to the tune of \$1,000,000) instigated this 34-charge indictment—making good on his campaign promise to "go after Trump in any way possible," just as NYS AG Leticia James did. (4)

Bragg has accused Trump of process crimes relating to a payment made seven years ago, whose statute of limitations has expired. Trump's former personal lawyer, Michael Cohen, claimed he made hush payments to porn star Stormy Daniels, to cover up an affair she had with Trump—which Trump denies. The payment was allegedly made in 2016, before the election. Cohen himself said the President did not know about the payment, as it was made through a shell corporation. Former mayor and Trump attorney Rudy Giuliani argues there were no financial violations because this was a personal matter. (5) Interestingly, the judge overseeing the case donated to the Biden campaign. (6) The story is still developing.

This is really being done out of fear that Trump will run and win again. The court case is scheduled for December, in the midst of the election campaign season. Opponents are hoping to tarnish his image enough for him to lose the presidential nomination. A popular term for this is 'Trump Derangement Syndrome'.

America has entered a two-tiered system of justice. It used to be defined as rich vs poor, now we define it as conservative vs liberal. "If there are two systems of justice, then there is no justice," says political commentator Mark Levin.(7)
